WHY DIRECT DEBIT?

We have implemented this Pre-Authorization Giving Plan at the request of Parishioners who have used it elsewhere in the past and found it meets their needs and lifestyle. This plan is not for everyone, but we are making it available to those who would like to use it.

We respect that giving is a very personal decision, but hope that the convenience and efficiency it brings might also encourage some parishioners to consider availing of this option. **Those who opt for this program can still use their offertory envelopes and indicate "PAG" on your weekly envelopes.** We look forward to your participation. If you have any questions, please do not hesitate to contact the parish office.

Cancellation of P.A.G Agreement

You may stop PAG **at any time** by simply writing a letter with 30 days' notice to Holy Family Parish. If you would prefer to use a standardized cancellation form instead of writing a letter, or for more information on your right to cancel your pre-authorized giving agreement please contact your financial institution or visit www.cdnpay.ca.

If a withdrawal is not consistent with this PAG agreement, you have the right to receive reimbursement. For more information on all your recourse rights, please contact your financial institution or visit www.cdnpay.ca

NOTE: If your bank reports an "NSF" in any month there will be a charge of \$5.00 to the Parish for each "NSF". We will advise you if this event occurs.

WHAT IS THE PRE-AUTHORIZED GIVING PLAN?

To accomplish the mission entrusted to us by Christ, Holy Family Parish depends entirely on the generosity of our parishioners. The Diocese of Hamilton has established a Pre-Authorized Giving Plan (P.A.G.) to assist you in your support of the work of Holy Family Parish through your regular parish offerings. **(this does not include the Building Fund and other special collections)**

On or near the 20th day of each month, your account will be debited an amount you specify. These funds are then deposited directly into the parish's account.

WHO LOOKS AFTER THE PLAN?

Parish pre-authorized giving programs are supported and encouraged by the Diocese of Hamilton through the Office of Stewardship and Development. For more information, please visit: www.hamiltondiocese.com

WHY SHOULD I PARTICIPATE?

Advantages for the donor:

- **Convenience** - Your offering is received automatically every month.
- **Continual support of your parish** when you are away.

Advantages for the Parish:

- Allows the parish to plan better through regular and dependable flow of contributions.
- Reduction of paperwork/bookkeeping

HOW DO I ENROLL?

This is how you make your gift through the Pre-Authorized Giving Plan:

1. Decide the amount of your gift to Holy Family Parish to be withdrawn from your account each month in support of the regular offertory.
2. Fill out the form in this brochure and attach a cheque from your account marked "VOID" or the equivalent form from your bank branch.
3. Use the following methods to submit your enrollment form by:
 - Drop off or mail to parish office
 - In the Sunday Collection Basket

Calculating your monthly pre-authorized giving

Weekly Amount = Monthly

To help determine the amount of one's monthly contribution, multiply your weekly offering by the 52 weeks in a year, then divide this annual contribution by 12. Examples are provided below for your reference.

Weekly Offering	Monthly Offering
\$10/week (\$520/year)	\$43 per month
\$20/week (\$1,040/year)	\$86 per month
\$40/week (\$2,080/year)	\$173 per month
\$50/week (\$2,600/year)	\$216 per month
\$100/week (\$5,200/year)	\$433 per month

Note that the amounts above are provided only for example. Our hope is that parishioners will contribute an offering that is meaningful, sacrificial, and that honours the abundance with which the Lord has blessed each of us.

Our parish office will issue tax receipts for all offertory gifts given via PAG.
